The availability of other funding sources, which may be more appropriate or available, such as developer's contributions (s106) will be taken into account when applications are considered.	
(7)	Provide a copy of your organisation's most recent bank statement	
(8)	Provide confirmation that the project is properly covered for insurance We may ask to see a copy of your insurance policy which should cover the period of the project.
