There is no obligation for you to adopt any particular solution contained in an Approved Document if you prefer to satisfy the relevant requirement in some other way. However, should it be alleged that you have contravened the regulations, providing you have followed the guidance set out in the relevant Approved Document that will be the evidence tending to show that you have complied. If you choose not to follow the guidance then it will be up to you to demonstrate by other means that you have satisfied the functional requirements of the regulations.
