#### **ADOPTION STATEMENT: FEBRUARY 2019**

In accordance with Regulation 26 of the Town and Country Planning (Local Planning) (England) Regulations 2012, notice is hereby given that on 4 February 2019 Blaby District Council formally adopted the Blaby District Local Plan (Delivery) Development Plan Document (known as the 'Delivery DPD').

The Delivery DPD was subject to examination by an independent inspector appointed by the Secretary of State, Ms Victoria Lucas LLB MCD MRTPI, who issued her report on the 21 December 2018. The Report concluded that, subject to the Main Modifications, the Delivery DPD was legally compliant and sound. The adopted, final version of the Delivery DPD includes all the Main Modifications recommended by the Inspector.

Any person aggrieved by the Blaby District Local Plan (Delivery) Development Plan Document may make an application to the High Court under Section 113 of the Planning and Compulsory Purchase Act 2004 on the grounds that:

- the Local Plan is not within the appropriate powers conferred by Part 2 of the Planning and Compulsory Purchase Act 2004;
- a procedural requirement has not been complied with.

Any such application must be made by no later than the end of the period of six weeks beginning the day after the Delivery DPD is adopted.
